Instructions for authors

Endoscopy International Open is a peer-reviewed international journal based on an open access model that publishes original contributions reporting on new developments in gastroenterological endoscopy. Clinical studies, preliminary results, original and review articles as well as short communications, case reports and case series are welcome. Submission and additional publication of video material is possible.

The editors decide upon acceptance, rejection or the need for revision and invite and encourage authors from all over the world to submit their results and to share them with the community.

As an open-access publication with 12 issues per year, all content is freely available online to all readers.

General policy

Only original material that has not been previously published and that it is not being considered or has been submitted for publication elsewhere may be submitted. The authors need to hold the copyright to the text and all illustrations (photographs, graphics, etc.).

In case of illustrations or photographs in which individuals can be identified, a written consent of the person involved must be submitted. Suitable forms can be downloaded from <https://www.thieme.com/en-us/who-we-serve/authors/journals>.

Please use preferably your own unpublished illustrations/tables/photographs/videos.

Important: If you intend to use figures or tables that have already been published, please contact the publisher directly to arrange the next steps (EIO.Thieme@hamilton-services.de).

The corresponding author declares with submission that the manuscript is submitted on behalf of all authors and that they have all participated in the work to be published in *Endoscopy International Open*.

In clinical or experimental studies with human subjects the study protocol must have been assessed and approved by the appropriate ethics committee. In the case of animal experiments, it is expected that the appropriate animal protection regulations have been followed.

Any potential conflicts of interest must be stated upon submission of the manuscript. A conflict of interest exists when one or more of the authors have a financial or personal connection that might influence their actions. The presentation of the topic must be neutral without any commercial recommendations.

Submission of the manuscript implies that the authors accept the *Endoscopy International Open* instructions for authors.

The authors accept in advance any necessary editing of the manuscript (including figures). The editors reserve the right to make any necessary changes or shortening in consultation with the authors.

Preprint Server Statement

Endoscopy International Open encourages the submission of manuscripts that have been deposited in an initial draft version in preprint repositories such as Research Square, arXiv, and medRxiv. Drafts of short conference abstracts or degree theses posted on the website of the degree-granting institution, and draft manuscripts deposited on authors' or institutional websites are also welcome. All other prior publication is forbidden.

During submission, authors should (1) note use of the preprint repository in the cover letter, (2) state what adjustments and/or updates the draft has undergone between deposition and submission and (3) cite the preprint, including the DOI, as a reference in the manuscript.

After submission to the journal, and until a final decision has been made, authors are discouraged from depositing versions of their manuscript as preprints. Upon publication authors should add a link from the preprint to the published article.

Patient identification

For publication of illustrations/photographs in which individuals can be identified, written consent of the person involved must be submitted to the publisher. Suitable forms can be downloaded from <https://www.thieme.com/en-us/who-we-serve/authors/journals>. Please be careful: the legal criteria for unrecognizability are strict: it should not be possible for anyone near that person to identify the individual.

Caution! All personal data relating to patient and/or examination (e.g. date, time, place, patient name, patient birth date, unique ID, examiner name or ID) must be removed from images and videos before submission. Findings/diagnoses and markings such as arrows are allowed. If your image or video contains technical parameters, please make sure that they consist only of complete, recognizable data that are essential for understanding the image. All images and videos displaying unexplained letters or numbers will be rejected.

Clinical Trials

Endoscopy International Open supports trial registration. All trials reported must be registered at an official registry recognized by the International Committee of Medical Journal Editors, such as ClinicalTrials.gov (www.clinicaltrials.gov) or any

of the primary registries on the World Health Organization's International Clinical Trial Registry Platform (www.who.int/ictrp).

Manuscript types

Endoscopy International Open considers the following types of paper for publication:

- Original articles
- Reviews
- VidEIO – video cases
- Letters to the editor/Letter replies
- Innovation forum

NB: For technical reasons, the following parts of your manuscript may only be entered in the relevant fields of the submission system (please delete them from the manuscript). Please note that only the information entered in the submission system for the points listed below will be published.

- Title
- Author names and affiliations
- Abstract
- Key words
- Funding information
- Info on clinical trial registration
- Conflict of interest

Original articles

Present results of original research, clinical studies or technical studies and should contain the following sections:

- Title (concise but informative)
- Structured abstract: (background/study aim, patients/materials and methods, results and conclusion, should contain all relevant statistical data of the results)
- Introduction: Background and aim of study
- Patients/materials and methods: outline of methods shall be given. In case of clinical studies the design must be stated (e.g. prospective, randomized, cohort, etc.) and the method and details of patient enrolment must be indicated.
- Results: Tables, figures or video clips may be used when they contribute to a better understanding of the results
- Discussion/conclusion: discussion and interpretation of the results. The conclusion should summarize the most important insights.
- Figure legends and tables
- Reference list (Literature references should be numbered according to the order in which they are cited in the text (i.e. not in alphabetical order). The reference numbers appear in square brackets in the text. Only references mentioned in the text are listed. References are cited according to the format below).
- Key words: 3 – 6 key words (preferably without repeating words in the title).

Length: abstract max. 250 words, main text max. 3500 words, 35 references

VidEIO – video cases

These short descriptions of interesting cases include a high quality video and a short explanatory text. Please see separate instructions for VidEIO at <https://www.thieme.de/de/EIO/authors-44180.htm>.

Innovation forum

The aim of the Innovation forum is to present new and special techniques that are at various stages of development, ranging from in vitro experiments to case series at single centers in which the technique was developed. The diagnostic and therapeutic techniques presented share the common features that they offer interesting and challenging approaches and that they have not reached the status of being fully clinically assessed. They are not yet state-of-the-art techniques in certain clinical situations, but may well become so in the future.

- The information shown above will appear in the journal on the first page of Innovation Forum contributions.
- Your contribution (excluding references) should cover a maximum of 2,000 words.
- Please include a **short abstract** (not structured).
- We encourage authors to include figures, especially in color. Schematic drawings are also reproduced in high quality by the publishers.
- A maximum of 10 references may be included. References should be cited numerically according to the Vancouver style: Number references consecutively in the order in which they are first mentioned in the text. Identify references in text, tables, and legends by Arabic numerals placed in square brackets. In the numbered reference list at the end of the text, use the style of the following example: Froehlich F, Burnand B, Vader JP et al. Endoscopies: Too many and not enough. *Endoscopy* 1997; 29: 713 – 705

Letters to the editor

Letters to the editor relating to published work in the journal are welcome. Letters should be closely related to the contents of the article they refer to.

Length: max. 500 words, 5 references

Publication of manuscripts immediately upon acceptance

EIO offers its authors the option to have their manuscripts published immediately upon acceptance and only after payment of the APC has been confirmed.

This means that the unedited, unformatted version of the manuscript as it stands after peer review is published online, with a DOI. Authors wishing to make use of this service will be asked to upload “clean” versions of their manuscripts after every revision; this is a precondition for this service, as is the confirmation that the Copyright Transfer Agreement (CTA) will be signed upon receipt.

This service is offered for Original articles, Reviews and Innovation Forum.

Implications of “accepted manuscript” publication

Once the paper has been accepted, the last clean version of the manuscript, including all metadata entered during submission (title, abstract, author affiliations etc.), becomes the first version of the article to be published online. This means that no changes can be made to the submitted clean version as this version will be published as the “Accepted Manuscript”, should it be accepted. Changes by the authors will only be possible subsequently in the proofs from the typesetters for correction. This means in detail:

- For all authors, the affiliation information entered during submission will be published.

- If an author is already in the system, please use “Edit” to update the address information if necessary.
- To facilitate the entry of co-author information, please use the “Quick Fill” option if applicable.
- The order of authors entered during submission will be the order of authors on the “Accepted Manuscript”.
- All authors named under step “Authors & Institutions” agree to the publication and signing of the CTA.
- The conflict of interest and funding information will be published as entered at the step “Details & Comments”.
- Clinical trial information will be published as entered at the step “Details & Comments”.

Instructions and further information are available during the submission process and upon request to the Editorial Office.

Acknowledgements

In this section, those individuals are listed who have made important contributions to the work without meeting authorship criteria as well as all independent organizations (such as the National Institute of Health [NIH]) that financially supported the work.

Videos

An article will be published once payment has been received. You may want to contact your funder about covering these costs. Many grant-giving bodies have special funds reserved for APCs.

Important copyright information for authors

All your submitted figures, tables and videos must be original work. They must be created fully by you and/or co-authors for the purpose of this publication. We cannot accept any material that has already been published in books, magazines or electronic products of other providers, including websites. We may also not publish any material to which a third party additionally has rights of use (e.g. your employer).

Please do NOT pay any license fees (e.g. for “RightsLink”/ Copyright Clearance Center) for any such material. Even the standard license agreements of “Creative Commons” cannot be recognized as proof that the material may be used.

If you are including any material that is not strictly text, you are required to provide the following information in the cover letter on submission:

- Confirmation that all figures, images, illustrations, tables and videos are original work created fully by you and/or co-authors for the purpose of this publication
- Confirmation that every component of illustrations that combine more than one element (e.g. pictograms, images, etc.), are your and/or co-authors’ own work
- Confirmation that you and/or co-authors hold all rights of use for every submitted figure, table and video and no third party holds rights of use

To summarize which material may not be used in your submission:

- Please do not use images that have already been published in books, magazines or electronic products (including websites)
- Please do not use images to which a third party additionally has rights of use (e.g. your employer)
- Please do not use even a small part of a third party image. Such images are not free from copyright protection even if they have been altered using a graphic editor
- Please do not use screenshots of third-party material (e.g. third-party websites, publications, etc.)
- Please do not use any Industry photography
- Please do not use logos of institutions, manufacturers or any other branding
